Safety Instruction Sheet for customers when inflatable play equipment is delivered.



TERMS AND CONDITIONS OF HIRE

It is the responsibility of the hirer to ensure that all possible steps are taken to avoid injury or damage to the inflatable. Please ensure that the following safety instructions are followed:

1. No food or drinks to be consumed on the inflatable. (to avoid choking & mess)
2. All shoes, badges, jewelry, (i.e., large earrings, necklaces etc.) MUST be removed. It is recommended that the spectacles are also removed.
3. No face-paints, party-poppers, colored streamers or silly string; must be used near or on the inflatable, as they can make a terrible mess and permanently stain the unit.
4. No smoking near the inflatable.
5. Climbing, hanging, or sitting on the walls is DANGEROUS and must not be allowed.
6. A responsible adult must supervise the INFLATABLE at all times.
7. Ensure that the inflatable is not overcrowded and limit the numbers depending on age and size of children using it. If the children collide with each other then it is too crowded.
8. Try to prevent large children and small children from using the inflatable at the same time. Some children require strict supervision.
9. If the inflatable is not being used for any part of the day, please switch the blower off at the mains, this will reduce your electric bill!
10. Do not allow anyone to bounce on the step/front apron. The step is there to help users get on and off.
11. Ensure that no-one with a history of back or neck problems is allowed on the inflatable.
12. Do not allow users to be on the unit during inflation or deflation.
13. In the event of heavy rain, it is strongly recommended that the inflatable be switched off. Any wetness, including bubbling, can be dried with a towel.
14. Ensure that the vent on the side of the blower is kept clear at all times.
